Wedding Policies

All weddings for both members and nonmembers are scheduled by working through the Minister of First Christian Church. Involvement by other Clergy is welcome, but this must be approved by the minister of F.C.C., and the minister of F.C.C. will be in charge.

Weddings held by other churches must be approved by the minister of F.C.C., and abide by our policies and regulations.

SMOKING is prohibited inside church. If you must smoke, please step outside the church.

NO ALCOHOLIC BEVERAGES permitted on the premises.

NO birdseed or rice can be used, and any materials to be thrown (rose petals, etc.) must be cleared with the Wedding Attendant.

The building will be opened 3 hours prior to the service and 1 hour following. All photography, preparation, etc. must be accomplished in this time period unless special arrangements have been made.

The Wedding Attendant will be present at all Sanctuary Weddings and will be paid \$10.00 an hour for the amount of time that the wedding party is in the building. (i.e. 5 hours = \$50.00, 3 hours = \$30.00, and so on)

In the event that a wedding (preparation time etc.) goes beyond 5 hours, there will be an additional Sanctuary usage fee of \$75.00, and a \$75.00 an hour charge for each subsequent hour.

The Wedding Attendant's hourly fee will be doubled for every hour beyond the five hours allotted for a Wedding. (i.e. 6 hours = \$70.00, 7 hours = \$90.00)

Wedding rehearsals are limited to one hour. All participants must be present on time at this rehearsal, or arrangements must be made to speak with the presiding pastor before the service.

Music details are worked out with the organist and are subject to the minister's approval.

Photographers must meet with the presiding minister before the service and abide by the minister's recommendations.

The wedding party must be out of the sanctuary area and in their designated preparation areas at least 30 minutes prior to the service (except in the case of individuals performing functions like ushering or greeting).

All photography must be completed at least 45 minutes before the service begins.

The presiding minister reserves the right to not allow any activities that are deemed disruptive or spiritually inappropriate. Likewise, the presiding minister has the right to refuse officiating at any service where respect for the Christian Faith and Christ's Church is not being displayed.
